PLEASE READ THIS AGREEMENT CAREFULLY

This license agreement is a legal agreement between you (either an individual or an entity) and Vision One Enterprises, Inc., DBA Vision One IT Consulting, Inc. By signing this agreement you are agreeing to be bound by the terms of this agreement.

DEFINITIONS: (a) "Vision One IT Consulting, Inc.," "we," and "us" means Vision One Enterprises, Inc. DBA Vision One IT Consulting, Inc., its subsidiaries, owners, investors, vendors, suppliers, executives and employees. (b) "You," "subscribers," "your", "user," and "users" means the individual or entity using Vision One IT Consulting, Inc. products or services. (c) "Data," means all files you have backed up to the Vision One IT Consulting, Inc. service, and any other records associated with your Vision One IT Consulting, Inc. account. (d) "Service" means all services provided by Vision One IT Consulting, Inc. (e) "Software" means the Vision One IT Consulting, Inc. application(s) installed on your computer.

GRANT OF LICENSE: This License Agreement permits you to use one copy of the Vision One IT Consulting, Inc. software on one computer/server, for purposes of accessing the Vision One IT Consulting, Inc. Service only. If you have signed up for multiple accounts with Vision One IT Consulting, Inc., this License Agreement permits you to use one copy of the Vision One IT Consulting, Inc. software on each computer/server. This license is non-transferable, and non-sub licensable.

COPYRIGHT: The SOFTWARE and accompanying materials (including any images, "applets", photographs, animations, video, audio, music and text incorporated into the SOFTWARE and accompanying materials) is owned by Vembu and licensed to Vision One IT Consulting, Inc. It is protected by United States copyright laws and international treaty provisions and all other applicable national laws. Therefore, you must treat the SOFTWARE and accompanying materials like any other copyrighted material (e.g. a book or musical recording) except that you may either (a) make one copy of the SOFTWARE solely for backup or archival purposes or (b) transfer the SOFTWARE to a single hard disk provided you keep the original solely for backup or archival purposes. You may not copy the documentation accompanying the SOFTWARE. You may not repackage the Software for further distribution by any means.

ACCEPTABLE USE: You are solely responsible for your behavior and your data stored and retrieved using the Vision One IT Consulting, Inc. Service. You agree to indemnify, defend, and hold harmless Vision One IT Consulting, Inc. and Vembu from any and all loss, cost, liability, and expense arising from or related to your data, your use of the Service, or your violation of these terms.

The Vision One IT Consulting, Inc. Software and Service are made available to you only for your personal use or for use within your own business, which use must be in compliance with all applicable laws, rules and regulations and must not infringe or violate third party rights. Any unauthorized use of the Vision One IT Consulting, Inc. Software, Service, servers or networks is a violation of this Agreement and

certain federal and state laws. Such violations may subject the unauthorized subscriber or user and his or her agents to civil and criminal penalties.

SERVICE-SPECIFIC RESTRICTIONS ON USE: Certain Vision One IT Consulting, Inc. products and subscription levels have certain limitations, including and not limited to the types of files you can back up, the schedule on which your backups operate, the bandwidth available to you, and the features available to you. You agree not to circumvent these limitations in any way, including and not limited to, and circumventing settings that do not have a user interface.

FILE PROTECTION: You are solely responsible for protecting the files on your computer by installing antivirus software, updating your applications, password protecting your files, and preventing third party access to your computer. You understand that Vision One IT Consulting, Inc. may back up files that are no longer usable due to corruption from viruses, software malfunctions or other causes. This might result in you restoring files that are no longer usable. If your Data contains viruses or other malicious code, Vision One IT Consulting, Inc. may deactivate this code as a by-product of its encryption features; however, Vision One IT Consulting, Inc. will back up this code along with your Data. Upon restoration, this code may become re-activated. Such viruses and malicious code backed up by any one user will not affect other users while it is stored with the Vision One IT Consulting, Inc. service.

FILE RETENTION POLICY: Vision One IT Consulting, Inc. may set file retention policies for some accounts, according to the features of the account to which you subscribe. Your account may allow you to edit these policies, which determine how long your files are stored on the Vision One IT Consulting, Inc. servers before they are deleted. You agree to carefully read and understand these file retention policies as they relate to your subscription, and to hold Vision One IT Consulting, Inc. harmless when it deletes data that falls outside the File Retention Policy associated with your account.

STORAGE SPACE QUOTA: Vision One IT Consulting, Inc. Vault accounts have storage levels. You understand that if you run out of space on the Vision One IT Consulting, Inc. storage servers, you will be upgraded to the next storage level. At which time you may elect to review your current storage level and have Vision One IT Consulting, Inc. modify the amount of data being backed up.

USERNAMES, PASSWORDS AND ENCRYPTION KEYS: Vision One IT Consulting, Inc. may require you to establish a Username, Password, and (optionally) an Encryption Key to protect your account and your Data stored with Vision One IT Consulting, Inc. You are solely responsible for any consequences that arise in whole or in part from your compromise of your Username, Password, or Encryption Key. Vision One IT Consulting, Inc. assumes no liability to supply you with your Username, Password, or Encryption Key. You understand and agree that Vision One IT Consulting, Inc. cannot access your Data, and that if you forget or lose your Username, Password, or Encryption Key, Vision One IT Consulting, Inc. may not be able to restore your Data.

Your Data is encrypted before it is sent to the Vision One IT Consulting, Inc. data centers, and remains encrypted when it is stored there. If you used a Private Encryption Key, Vision One IT Consulting, Inc. cannot view the data you back up using the Vision One IT Consulting, Inc. service. If you forget your

Private Encryption Key, you will not be able (and Vision One IT Consulting, Inc. cannot assist you) to restore your Data.

CONSENT TO COLLECT INFORMATION: The Vision One IT Consulting, Inc. service may collect nonpersonally identifiable information that resides on your computer including, and not limited to, statistics relating to backup times and status, performance metrics relating to the Vision One IT Consulting, Inc. Software, configuration settings, but not the contents of your files. The information collected will be used only to improve our service to you.

TERM: This Agreement becomes effective when you register for Vision One IT Consulting, Inc. services. It remains in effect until your account is terminated. **TERMINATION:** You may terminate this Agreement at any time by uninstalling the Vision One IT Consulting, Inc. Software and canceling your subscription, following the instructions on the Vision One IT Consulting, Inc. web site.

This Agreement automatically terminates if you fail to comply with this Agreement. Vision One IT Consulting, Inc. reserves the right to refuse or discontinue any subscription at any time at its sole discretion. You agree that, upon termination, you will uninstall the Vision One IT Consulting, Inc. software and that your subscription and access to the Vision One IT Consulting, Inc. service will immediately terminate.

Upon termination of paid accounts, Vision One IT Consulting, Inc. will use reasonable efforts to make your data available for you to download for a period of seven (7) days.
